9 I, Matthew R. Walsh, declare I am the Plaintiff in this matter. I have personal
10 knowledge of the following facts and if called as a witness I could and would
11 testify competently hereto. All text, images and exhibits herein are true and
12 accurate copies which I have received or have made and I am authenticating all of
13 them under the penalty of perjury.

Plaintiff sought to defeat Defendant’s nerve-center argument when filing the Motion to Strike Removal (later partially withdrawn to instead only seek jurisdiction reclassification of Federal Jurisdiction as “Federal Question”)

1. Plaintiff filed (Dkt #70) which undisputably destroys Diversity Jurisdiction. Defendant has never opposed the information or denied it.

2. Plaintiff demonstrated with Defendant’s own Secretary of State records that:

- a. Jakob Balslev lists himself as the Founder, CEO, CFO and Secretary making *him* the nerve-center of the Company. (Exhibit 1)

- b. To defeat diversity, Counsel authored “personal declarations” purporting to be from Defendant Mikkel Overby (Denmark) claiming he was the CFO and COO (Exhibit 2). DocuSign records show Defendant did not author these statements himself, Counsel did – and further CFO is not listed as his title there either (Exhibit 3)

35 c. The CEO, CFO and Secretary is actually listed as Jakob Balslev on
36 official paperwork.

37

38 3. Defendant's claim that Jakob left California in 2020 wasn't true as Secretary
39 of State Records show that he registered Rokoko Electronic, Inc. to his
40 personal luxury apartment at 4140 Cesar Chavez St, San Francisco, CA
41 throughout 2024. (Exhibit 4)

42

43 4. Within four days of this information being filed with the Court, Defendant
44 contacted the SOS and made changes to the records – appointing a
45 retroactive registered agent and then having the entire year of 2023 removed
46 altogether. (Exhibit 4)

47

48 5. Defense *had to hide this information* or diversity would be defeated, the case
49 could be remanded and they would be defaulted immediately in State Court
50 or worse, it would be evident that they perjured themselves; especially since
51 they did not disclose to the Court they owned a commercial property in San
52 Francisco, in the businesses' name and have paid property taxes since 2016
53 while employing staff at it. (Exhibit 5)

54

55 **6. HOW IT WAS DONE**

56 a. Defendant first superseded with a new SOI (statement of information)
57 to overwrite his name, personal address and other information with a
58 registered agent instead.

59 b. Defendant *then* filed a Form CORR-CORP (Exhibit 6) and paid
60 a \$30 fee; this form allows records to be marked "false or erroneous"
61 or "defectively signed". The remedy is removal of the offending
62 filing(s).

63 c. **TIMELINE MATCH:** The current state timeline for these filings to
64 be addressed: **four days**. Precisely the amount of time it took the
65 Defendant's to have their records removed. (Exhibit 7)

66
67 **7. DEFENDANT CANNOT DENY**

68 When confronted with admitting that California-domiciled Jakob Balslev is
69 the CEO, CFO and Secretary (thereby the Nerve-Center), Defendant
70 **admitted.**

71 **8. REQUEST FOR ADMISSION NO. 11.** Admit that Jakob Balslev is the
72 CEO, CFO, and Secretary of Rokoko Electronics.

73 a. **RESPONSE TO REQUEST FOR ADMISSION NO. 11.** *In*
74 *addition to the General Objections set forth above, Rokoko objects*

75 *that this Request is overbroad as to scope and time and irrelevant to*
76 *the claims in this action. Subject to and without waiving any of its*
77 *objections, Rokoko responds as follows: Admitted that Jakob Balslev*
78 *is Rokoko s CEO.*

79 9. When confronted with the commercial property issues in RFA's, Defendants
80 refused to deny:

81 a. **REQUEST FOR ADMISSION NO. 3.** Admit that in Defendants
82 filings concerning jurisdiction, Defendants did not disclose the
83 property located at 44 Tehama Street, San Francisco, California.

84 i. **RESPONSE TO REQUEST FOR ADMISSION NO. 3.** *In*
85 *addition to the General Objections set forth above, Rokoko*
86 *further objects to this Request to the extent that it seeks*
87 *information that is not relevant to a claim or defense of any*
88 *party and/or not reasonably calculated to lead to the discovery*
89 *of admissible evidence. In his Notice of Partial Withdrawal of*
90 *Motion, Plaintiff withdrew Motion to Strike as it pertained to*
91 *jurisdiction and acquiesced to the jurisdiction of this Court.*

92 (The motion was never withdrawn, this is false)

93 10. When confronted with Overby's e-mail IP traces all resolving 300km away
94 while claiming he signed those declarations from Copenhagen (and
95 DocuSign proving otherwise), Defendants refused to deny:

96 a. **REQUEST FOR ADMISSION NO. 47.** Admit some or all of your
97 senior staff lives and works in or around Tranbjerg.

98 i. **RESPONSE TO REQUEST FOR ADMISSION NO. 47.** *In*
99 *addition to the General Objections set forth above, Rokoko*
100 *objects to the extent that this Request is overbroad as to scope*
101 *and time. Rokoko further objects that this Request is unduly*
102 *burdensome and harassing insofar as it seeks private and*
103 *personal information unrelated to any of Plaintiff's claims.*
104 *Rokoko further objects to this Request to the extent that it seeks*
105 *information that is not relevant to a claim or defense of any*
106 *party and/or not reasonably calculated to lead to the discovery*
107 *of admissible evidence.*

108 11. When confronted with ReedSmith authoring Mikkel Overby's declaration,
109 Defendant refused to deny:

110 a. **REQUEST FOR ADMISSION NO. 36.** Admit that Mikkel
111 Overby's second declaration contains a DocuSign signature because it
112 was drafted by ReedSmith and sent to him for signature.

113 i. **RESPONSE TO REQUEST FOR ADMISSION NO. 36.** *In*

114 *addition to the General Objections set forth above, Rokoko*
115 *objects that this Request fails to identify the second declaration*
116 *with sufficient particularity, rendering the Request vague and*
117 *ambiguous such that Rokoko is unable to formulate a response*
118 *or otherwise admit in good faith. Rokoko further objects that*
119 *this Request is improperly compound and overbroad as to time*
120 *and scope. Rokoko further objects that to the extent that this*
121 *Request seeks information protected by the work product*
122 *doctrine, attorney client privilege, or any other applicable*
123 *privilege. Rokoko further objects that the methods by which*
124 *Rokoko drafts litigation documents is not relevant to any claim*
125 *or defense of any party to this action.*

126 b. **REQUEST FOR PRODUCTION NO. 14.** Produce all non-
127 privileged documents concerning the preparation, drafting, or
128 execution of the declarations of Mikkel Overby or Katherine J. Ellena
129 filed in this action, and provide a privilege log identifying any
130 withheld documents.

131 i. **RESPONSE TO REQUEST FOR PRODUCTION NO. 14.**

132 *In addition to the General Objections set forth above, Rokoko*

133 *objects to the Request to the extent it calls for the disclosure of*
134 *privileged or protected information, including without*
135 *limitation, information subject to the attorney-client privilege,*
136 *attorney work product doctrine, or any other statutory or*
137 *common-law privilege. Rokoko further objects that this Request*
138 *is clearly harassing insofar as it seeks to uncover Rokoko's*
139 *attorney work product, completely divorced from any relevance*
140 *to Plaintiffs claims. Rokoko further objects that this Request is*
141 *not reasonably calculated to lead to the discovery of admissible*
142 *evidence.*

178 Tranbjerg, Midjylland — approximately 300 km (4 hours) away — where Overby
179 in fact resides and works.

181 The metadata further confirms that the declaration was transmitted *to* Defendant
182 *from* counsel and signed within 90 seconds of receipt, demonstrating that the
183 declaration was drafted by counsel and merely rubber-stamped by Overby, not
184 authored by him under penalty of perjury.


