2 **PLEASE TAKE NOTICE:** Plaintiff respectfully submits this Notice of Errata

4 regarding Plaintiff's Motion to Strike Removal, Docket #49 filed on 7/3/2025.

6 As set forth in Plaintiff's motion, Defendants' diversity allegations are
7
8 demonstrably false, contain false statements, omissions and cannot support
9
10 jurisdiction under 28 U.S.C. § 1332. Insofar that, Defendant has provided no
11
12 amount of non-conclusory evidence to satisfy their burden of proof to the contrary;

14 Plaintiff instead clarifies that federal-question jurisdiction was always the proper
15
16 basis for removal under 28 U.S.C. § 1331, as Plaintiff's Complaint raises claims

18 under the Digital Millennium Copyright Act and the Copyright Act; of which

20 substantial damages are sought.

21 **PLAINTIFF RESPECTFULLY** withdraws all requests for vacatur or remand

23 especially in the prayer for relief section on page 16; and within his prayer for
