**[PROPOSED] ORDER**

On October 15, 2025, Defendant Rokoko Electronics (“Rokoko”) filed its Omnibus Motion to Quash Subpoenas and To Issue a Protective Order (“Motion”) pursuant to Federal Rule of Civil Procedure 45.

Rokoko requests this Court quash Plaintiff Matthew R. Walsh’s (“Plaintiff”) subpoenas in their entirety.

The Court, having considered Rokoko’s Motion and finding good cause therefore, hereby GRANTS the Motion and ORDERS as follows:

1. The subpoenas issued by Plaintiff on DocuSign, Inc.; c/o United Agent Group, Inc., Trifork US Inc., Naver Z USA, Inc., Internet Archive, Wikimedia Foundation, and Corridor Digital, LLC from September 12 through September 15, 2025 are hereby quashed in their entirety; and,
2. The subpoenas issued by Plaintiff on DocuSign, Inc.; c/o United Agent Group, Inc., Trifork US Inc., Naver Z USA, Inc., Internet Archive, Wikimedia Foundation, and Corridor Digital, LLC on or about September 26, 2025 are hereby quashed in their entirety.
3. A protective order is granted preventing Plaintiff from attempting to serve future subpoenas in this action without first obtaining approval from this Court.
