14 I, Matthew R. Walsh, declare as follows:

15
16 I am the Plaintiff in the above-captioned matter. I submit this supplemental declaration in
17 further support of my **MOTION TO STRIKE DEFENDANTS REMOVAL**. I have personal

18 knowledge of the facts set forth herein and, if called to testify, could and would competently do
19 so.

20
21 **BACKGROUND**

22
23 1. This action arises from Plaintiff Matthew R. Walsh’s claims against Defendant Rokoko
24 Electronics and its affiliated entities and individuals. Defendant has filed a Notice of
25 Removal to federal court, asserting grounds that Plaintiff contends are procedurally and
26 substantively defective. Plaintiff now seeks to strike that removal and all associated
27 filings based on evidence showing Defendant’s significant and longstanding presence in
28 California, and the improper conduct of Defendant’s legal representatives.

29
30 2. From as early as 2015, Defendant’s CEO relocated to San Francisco to launch what
31 became Rokoko, originally branded under the name “Salto,” through a Kickstarter
32 campaign. Since then, Defendant has continuously represented a base of operations in
33 California. Defendant’s CEO and co-founders have publicly identified their residence and
34 business activities as centered in San Francisco and the greater Los Angeles area,
35 including purchasing real estate, attending business conferences, incorporating entities,
36 and soliciting funding.

37
38 3. Defendant has maintained physical offices and staff in both San Francisco and Los
39 Angeles, regularly advertised shipping from U.S. warehouses, and catered to a
40 California-based consumer market. Defendant further opened U.S. bank accounts,

41 operated subsidiaries, and accepted substantial investments through California channels,
42 including from the Los Angeles-based firm Naver Z.

43
44 4. In parallel, Defendant's removal filing and associated pleadings were executed and
45 submitted by individuals who were not admitted to practice before this Court and lacked
46 pro hac vice status, including Michael Galibois and Emily Graue. Despite repeated meet
47 and confer efforts by Plaintiff, Defendant's counsel continued involving these unadmitted
48 attorneys in official legal communications, filings, and appearances, raising serious
49 questions about unauthorized practice of law and the legitimacy of the removal filing
50 itself.

51
52 5. The evidence demonstrates not only that Defendant is deeply rooted in California for
53 jurisdictional purposes, but also that its removal was filed through irregular and improper
54 channels, undermining its validity.









Thanks for your note, Mr. Walsh. We understand you’re not inclined to agree with any points of law or fact we offer. That’s ok. Both sides can agree to disagree. Not uncommon at all—we can let the court to decide. But as you asked for our position, it is clear that removal divests the state court of jurisdiction until your remand motion is decided in federal court. The state court equally will understand this point. So, we intend to oppose your remand motion. If remand is denied (which is our position it clearly should be), then the matter will proceed in federal court. If remand is granted (as is your position), the matter would be remanded to proceed then in state court.

Hope this is helpful at least in confirming our position.


